

TREASURER'S REPORT

The 2017 year has been very similar to 2016. The General offerings were slightly higher only because we had more members passing away. We were able to maintain general offerings while also losing members.

Chinese Presbyterian Church will start the rebuilding process in 2018. With the sale of the duplexes to be completed at the end of 2018, we will have the funds available to build our new church. The new building will allow us to rebuild our education ministry as well as provide more outreach potential.

If the projected deficit materializes, funds will be transferred from Designated Operating Funds to cover any operating shortfall. Designated Development Funds will be used to pay for development and building costs.

The 2018 Budget includes the following:

- · General receipts will remain similar to 2017
- · VBS, Summer Conference and Awana will continue assuming receipts and costs will remain similar to 2017
- · Nursery and Chinese Schools will have a decrease in students
- Rental income will be received for 9 months. Two units will not be rented due to the expected repair costs exceeding the rent that could be received during this period of time
- · Minister's Office expenses will be decreased as we will only have one fulltime Minister. However we will still be paying for a 2nd Minister for at least 6 months (this could be more depending on when a settlement can be completed by Presbytery). The Youth Minister is only paid for 2 months as he leaves at the end of February.
- · Pulpit supplies has been increased so one speaker can be engaged approximately once a month.
- · Church programs will remain similar to 2017 except we have added some funds for the Mandarin Ministry

We always welcome more volunteers to participate in the weekly operations like counting and data entry. Anyone who has the expertise or the willingness to learn would be appreciated. Thank-you to Glady and Marleen who have taken responsibility for the Sunday counting. Thank-you to all the counters and data entry volunteers. Thank-you to Pearl who continued to assist in the 2017 payroll processing.

REVIEW ENGAGEMENT REPORT

We have reviewed the accompanying financial statements of Chinese Presbyterian Church that comprise the balance sheet as at December 31, 2017 statements of changes in net assets, operations and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for private enterprises, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

FOR DISCUSSION PURPLE based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally acepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

PURPOSE OF ORGANIZATION

The purpose of the Church is to provide a place to hold worship services, and to provide ministries for women, men, youth and children, preschool and pastoral care to those in need.

2. BASIS OF PRESENTATION

FOR DISCUSSION PURPOSES ONLY These financial statements have been prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations.

SIGNIFICANT ACCOUNTING POLICIES 3.

The Financial statements have been prepared in accordance with generally accepted accounting principlessummarized as follows:

FUND METHOD ACCOUNTING

The Church follows fund method of accounting.

The Congregation Fund accounts for the assets, capital, receipts, and expenditures of the Church's operations excluding its trust liabilities.

The Unrestricted Designated Fund accounts for funds that have come to the Church through donations. bequests and by allocation from the Congregation Fund. They are internally reserved for specific purposes.

The Restricted Designated Fund accounts for funds reserved for building a new church.

The Endowment Fund accounts for donations and bequests reserved for specific purposes. The unexpended income may be allocation to the Congregation Fund.

The Manse Fund accounts for the fund from sale of the Manse after paying off all the related expenses. It is internally reserved for purchasing a new manse in the future, or the capital is reserved to earn interest, of which the interest can be used for minister's living allowance. Any use of the manse fund capital or access of the interest requires approval of the Presbytery.

FINANCIAL INSTRUMENTS

The financial instruments of the Church consists mainly cash, accounts receivable, accounts payable and accrued liabilities.

FOR DICULTSION PURPOSES ONLY

The fair value of the Church's cash, accounts receivable, accounts payable and accrued liabilities approximate their carrying amounts due to the relatively short periods to maturity.

The Church has elected not to disclose fair value information about financial assets and liabilities for which fair value was not readily available.

3. SIGNIFICANT ACCOUNTING POLICY (Continued)

LIKAF I FOR DISCUSSION PURPOSES ONLY

SHORT-TERM INVESTMENTS

Short-term investments, consisting of short term notes, fixed income funds and shares of publicly traded companies, are measured at fair value. Changes in fair value are recognized in net income in the period incurred.

PROPERTY AND EQUIPMENT

Property and equipment are recorded at cost with depreciation and amortization provided as follows:

Rate Method

Buildings

30 years

Straight-line

Furniture and equipment

15 years

Straight-line

In the year of acquisition only one-half the normal rate is applied.

REVENUE RECOGNITION

Revenue from sales and service transactions are recognized when the requirements as to performance are satisfied, provided that at the time of performance ultimate collection is reasonably assured.

MEASUREMENT UNCERTAINTY

The preparation of financial statements, in accordance with Canadian generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. These estimates are reviewed periodically and as adjustments become necessary, they are reported in earnings in the period in which they became known.

4. NOTES RECEIVABLE

FOR DISCUSSION PURPOSES ONLY

The Church advanced \$7,000 to a former youth minister for his education. The advances bear interest at 4% per annum. The interest and advances are to be repaid on or before February 19, 2020.

FINANCIAL INSTRUMENT RISKS AND CONCENTRATION OF RISK 6.

The Church may expose risks through its financial instruments. The following provides analysis on the Church's risk exposure and concentration at the reporting date:

Credit risk:

FUN DISQUESTAN PURPORES ONLY Credit risk is the risk that a third party to a financial instrument might fail to meet its obligations under the terms of the financial instrument. The Church's accounts receivable are interest receivable. It is the management's opinion that the Church does not expose to significant credit risk.

Liquidity risk:

Liquidity risk is the risk that the Church will encounter difficulty in meeting financial obligations as they come due. As at the balance sheet date, the Church has sufficient cash to settle its current liabilities. Hence, the Church does not face liquidity risk.

Currency risk:

Currency risk results from exchange rate fluctuations and the volatility of these rates. All the Church's transactions are denominated in home currency and hence it does not expose to any currency risk.

Interest rate risk:

The Church does not carry any interest bearing financial instruments with floating interest rates. It does not expose to interest rate risk.

REBUILDING OF CONGREGATION

But you are a chosen race, a royal priesthood, a holy nation, a people for God's own possession, so that you may proclaim the excellencies of Him who has called you out of darkness into His marvelous light.

1 PETER 2:9

The church theme for 2017 is "Rebuilding of Congregation". It is the second year of a three year series. Previously, in 2016, the church theme was "Rebuilding Lives", and in the subsequent year in 2018, it will be "Rebuild the House of the Lord".

In this theme "Rebuilding of Congregation", I focused my sermon series on the characteristics and the functions of the church; a general introduction of Psalms; and the special identity of Jesus from the Gospel according to John. I once again invited those brothers and sister who had received theological education to participate in the pulpit ministry; including Anderson Zeng, Leo Wong, elder Tim Tam and elder Remy Fu. I also organized a one day preaching workshop for the elders, encouraged them to involve in this area of ministry. Elder Diana Wong and elder John Con preached respectively in the Chinese and English worship services. We all witnessed their amble preparation and humility to learn. Their powerful words benefitted many of us. 2017 marks the 500th anniversary of the Reformation. In the beginning of the year and on the Reformation Sunday, October 29, I myself and elder Remy Fu preached on this special and momentous occasion.

In the Chinese Bible Study group, we studied 1st and 2nd Samuel. We explored the life and ministries of Samuel, the prophet, who faithfully served the Lord. During his ministry journey, he anointed Saul and David as kings; as well as witnessed the enormous shift of a God-governing nation to a country ruled by kings. In the Ladies Bible Study, we studies Paul's letters to the Galatians and Ephesians (one of Paul's prison epistles). In the process of study, all ladies were very engaged in the discussion, learning the Biblical principles and applying them to their own daily living situation.

During the summer, our church had our Vacation Bible School. This year was no exception. We thank Lela Ling for leading this vital ministry. The theme was "Maker Fun Factory: Created by God, Build for a Purpose" (please read the separate Report). As for the Summer Conference, we thank the Lord for providing Rev. Dr. David Chan who is the vice principal of the Alliance Bible Seminary from Hong Kong to give to the Chinese congregation a four part series from Nehemiah who rebuilt the Holy City of Jerusalem. He challenged us while our church was going through the rebuilding process. For the English congregation, we were blessed to have Rev. Dr. Ross Lockhart and Rev. Dr. Robert Paul from our own seminary locally to speak to us about different models and practical strategies on church growth.

Although the enrollment of 2017-2018 A.W.A.N.A. had dropped to seventeen children, those kids who came had tremendous fun in learning the Bible golden verses, games and songs. I would like to thank all the volunteers, who served diligently and quietly, sowing the gospel seeds to this group of children.

The Property Development Task Force thanks the leadership of elder George Sze. We had a total of six meetings. We praise the Lord as our Rezoning Application was approved by the city (please read the separate Report). Many thanks to the PDTF members.

At the November Presbytery meeting, Rev. Alexander applied for a three month sick leave, effective immediately. Please remember him in your prayers.

In the past year, eleven elderly members passed away and joined with our Lord. Among them, three were our respected elders. Like the apostle Paul said, "⁷ I have fought a good fight. I have finished the work I was to do. I have kept the faith. ⁸ There is a crown which comes from being right with God. The Lord, the One Who will judge, will give it to me on that great day when He comes again. I will not be the only one to receive a crown. All those who love to think of His coming and are looking for Him will receive one also" (2 Tim. 4:7-8, NIV). We also had five new members, they were: Simmy Wong, Tania Wu, Bruce Li (by Baptism); David Chen and Edith Cai (by Transfer).

In order for a church to strive and to expand her ministries, it is the responsibility of everyone. It requires the participation and involvement of brothers and sisters. I would like to thanks all the elders, Board of Managers, the Treasurer and many volunteers, who served faithfully with their minds and strength, dedicated their services to the Lord, prepared God's people for works of service, so that the body of Christ may be built up, to achieve the theme of our church – Rebuilding of Congregation!

MY REFLECTION OF THE YOUTH MINISTRY

When I was first called to serve as Youth and Young Adults Pastor at Vancouver Chinese Presbyterian Church, I had the conviction that the youth are the future of the church. It is only right that people want to rightfully acknowledge that someday the youth in our churches will grow up to become our Elders, deacons, and leaders, while doing great things for Jesus. The problem is, that idea implies that youth are not doing great things for Jesus *right now* which I think it is just is not true. I truly believe that we have youth who are doing unbelievable things for Jesus right now in the church. We have the opportunity to help our youth see that they are not just the future of the church, but a real and vital part of the church right now. The youths are not potential members, or disposable parts of the body of Christ. They can play an absolutely critical role in the ministry of the church if we let them. Unfortunately, there is a culture in the church that does not put a lot of emphasis on developing their spiritual formation. As a result, there is a lack of motivation for the youth to take ownership of the church or their spiritual lives. I came to this conclusion after spending the better part of 2017 leading the Youth Ministry at Vancouver Taiwanese Presbyterian Church including my duties at Vancouver Chinese Presbyterian Church since April 2017.

Embracing the Mark 8:36 Principle

The Christian life is a paradox: to attempt to keep your life means only to lose it. A person who keeps his or her life in order to satisfy desires and goals apart from God ultimately loses life. Not only does that person lose the eternal life, he or she loses the fullness of life promised to those who believe. By contrast, those who willingly give up their lives for the sake of Christ and of the gospel actually find true life. To give up one's life for Christ's sake refers to a person refusing to renounce Christ, even if the punishment were death. To be willing to put personal desires and life itself into God's hands means to understand that nothing that we can gain on our own in our earthly lives can compare to what we gain with Christ. Jesus wants us to choose to follow him rather than to lead a life of sin and self-satisfaction. By extension, I see a difference in the spiritual formation of the youths at VTPC and the youths at VCPC. One of the biggest differences is their response to the Word and their willingness to engage and wrestle with it. This is seen in their motivation to come to church and their interactions with me. For the longest time, I did not know why, but I finally understood: the parents embrace the principle of Mark 8:36. In other words, the parents put secular obligations and priorities as secondary. It is understood that life is busy and because of this, priorities have to be made. The parents motivate (not impose) God as an important priority in their lives. This habitual inclination to put God first started when the children were young and this desire to have God in the centre of their lives is wired into their very being. Like our youths, there are gifted academics and gifted athletes at VTPC, but God comes first. In the bigger picture, the parents and the children do not feel that investing 2 or even 4 hours a week for God on the weekend is a sacrifice of their time.

To illustrate their priority in the their son's spiritual development, one parent shared with me that his son could be the next *Jeremy Lin*, but at what cost? Having a healthy relationship with God will build Godly checks and balances in his life that if truly makes it, he will not be seduced by the attractions of that life.

There are times that I wish I could have an honest dialogue with some parents, but, it is a very touchy subject as I am very aware that the secular lives of our youths are extremely important to them. One of my

biggest fears is for me to encounter our youths in the future and they share with me that God is no longer a priority. I truly hope that parents take a hard look at the spiritual formation of their children and measure the cost of their salvation at the expense of academic and/or athletic accolades.

Youth Service

When I was serving at Evangelical Chinese Bible Church before coming to VCPC, I saw a need to have some form of Youth Service where there is some sort of organized worship and not just simply a Sunday School type of structure on Sunday. The service had worship, Biblical readings, sermon and a benediction. I felt that this was beneficial as the youth were taking ownership of the service as they were participants and not merely spectators. I suggested this idea to Rev. Bartholomew on many occasions, but each time he turned me down. His rationale was that they did not want to divide up the English service up into two services. In addition, he felt that if the youth wanted to come to service, they could attend the regular service. Unfortunately, this was not viable as the majority of the youth are the children of the parents who attend the Chinese Service. It is highly doubtful that the parents will come to the English Service with their children and then attend the Chinese Service while their children attend Sunday School. It was not until this past summer that I was able to have a Youth Service during the months of July and August. While it was short, I saw a lot of fruit from the two months that we had Youth Service. I could see the seeds that I planted as some would recall what I preached about, but more importantly, they took ownership of the service as they participated in the reading of Scripture. It is my prayer and hope that the youth to lead the English Service one a year or twice a year, but not just in terms of the Youth Orchestra, but actually participating in the service with exception to the sermon of course. Even better would be to have a service for the youth between the English and Chinese service times.

Youth Participation in the Church

In terms of the youth currently participating in the church, some play in the Youth Orchestra and some play for the Chinese Choir. While both are worthy places to serve the church, it has been a distraction to their spiritual formation. Some have shared with me that they don't mind serving, but not in both capacities. In their busy lives with so many commitments, it hard for them to juggle two church commitments on a Sunday. More importantly, those youths who are asked to play for the Chinese Choir lose their opportunity for spiritual food on that given Sunday because they are unable to attend Sunday School. We have some youths in the group who are very close to leaving the church because I can see that their spiritual life is not a priority for them. For them, it is important for them to attend Sunday School instead of playing for the Chinese Choir. Of course, I am fully aware that there is a lack of people who can play the piano for the choir, but we need to look at our priorities. I have stated on many occasions that the church is one generation away from extinction. Leonard Sweet who is considered one of the 50 more Influential Christians observed, "The church doesn't lose its kids when they go to college. We lose them much earlier: in middle school most, high school next, college last." If that is the reality the church is facing, wouldn't it

confident that there are adults within the Chinese congregation who can play piano, but either are too shy or needs convincing to serve the church in this capacity.

As I leave VCPC at the end of February, I am reminded of Paul's words in 1 Corinthians 12:13: "Some of us are Jews, some are Gentiles, some are slaves, and some are free. But we have all been baptized into Christ's body by one Spirit, and we have all received the same Spirit."

Paul stresses that each believer has a significant contribution to make and it is why he uses the analogy of the body, Paul emphasizes the importance of each church member. If a seemingly insignificant part is taken away, the whole body becomes less effective. That is why the whole church body has a role in the Youth Ministry. I am truly grateful to all the elders and those attending who have supported me through prayers and advice during the past 2 years at VCPC. I leave here with a sense of sadness as I will not be part of the new era at VCPC with the commission of a new building, but at the same time excited at to what God has planned with His people at VCPC. It is my prayer and hope that I was able to plant some seeds into the lives of the youths at VCPC so that God will convict them to be the next leaders of the church, but more importantly, faithful Christ-followers.

REV. BARTHOLOMEW ALEXANDER - UPDATE

-Following the Presbytery Visitation Team's visit to VCPC, they reported on March 7, 2017 to Presbytery

that there were differences between Rev. Alexander & the leadership at VCPC. Subsequently, Presbytery appoints a Facilitator to VCPC to determine whether the differences between the parties could be resolved. After a year long review and attempt to reconcile the parties, the Facilitator concluded that the relationship between Rev. Alexander and the leadership of VCPC were strained, that the situation is not healthy and appears to be worsening, that the working relationship between the two Ministers and between Rev. Alexander and Session are not viable going forward.

-Two options were presented to VCPC and Rev. Alexander:

- 1. Both parties could waive their right to a review process and request that Presbytery dissolve the Pastoral Tie, or
- 2. Presbytery on the recommendation of the Ministry Committee could move towards a formal "Review of Ministry" process. This latter option according to the Committee "seemed a non-starter given the dire situation with the pastoral tie".
- -In late October 2017, both VCPC and Rev. Alexander requested that Presbytery/Ministry Committee dissolve the pastoral tie between VCPC and Rev. Alexander. Presbytery then drafted a report and recommendations to be considered at the Presbytery Meeting of November 7, 2017. The Settlement Agreement drafted by Presbytery included that Rev. Alexander be given a Leave of Absence to cover the period up to the effective date of Dissolution; and both parties agreed to a transition allowance of 6 months which is above the 4 month minimum that would be applicable in this situation in accordance to the Presbyterian Church of Canada's dissolution policy.
- -Then on or about October 26, 2017, Rev. Alexander obtained a "Work Absence Certificate" from his physician saying that effective Nov. 4, 2017 to Feb. 4, 2018 he will not be well and will not be able to work.
- On October 27, 2107 Rev. Alexander confirms to the Clerk Presbytery that he is requesting Presbytery to dissolve the tie. The Clerk also confirms with Rev. Alexander that he accepted the Leave of Absence and to the terms of the settlement.
- However on November 6, 2017, the day before the November 7, 2017 Presbytery Meeting when the matter of the dissolution was to be discussed and voted on, Rev. Alexander changes his decision, and forwards his Work Absence Certificate that he had obtained on October 26, 2017 to Presbytery and VCPC, advising Presbytery that he was not well and asks Presbytery not to proceed with the dissolution of ties at this time. Presbytery on receipt of Rev. Alexander's Work Absence Certificate, placed him on medical leave.
- -We ask for your prayers for Presbytery and the Ministry Committee, for Rev. Alexander, Rev. Wong, the Session and congregation of VCPC
- -The above summary of events submitted by Clerk of Session

BOARD OF EDUCATION

The Board of Education at Chinese Presbyterian Church was established by Session in October 2016 in-order to provide oversight over the two privately funded schools under the sponsorship of the Church. The two schools are the Preschool and the Chinese Language School. Oversight includes determining the budget, the recommended curriculum, and any issues that may impact the life of the church, the teachers, and the students.

The purpose of the Board is to provide support, guidance and counsel to the supervisor or principal of the schools. The Board has the power to establish the mission, set goals and give strategic directions to the schools and more importantly to ensure a strong nourishing and safe environment for the growth and development of young children in their formative years that is physically, emotionally and spiritually. The Board ensures proper implementation and evaluation of basic requirements for a healthy learning environment for both students and teachers.

The Board has established a Term of Reference that sets out its accountability and functions. The organizational chart of the Board consists of the chair who reports to the Session as necessary; a treasurer who does the budget; a secretary that keeps minutes of the meeting efficiently; as well as the supervisor and principal of the schools who oversee the day to day operation of the schools. Needless to say, the current Board members are servant leaders by God's grace. The current active members of the Board and officers are: Linda Sze as Treasurer; Lela Ling, the Secretary and the Chair Remy Tam as voting members. Samantha Chan and Grace Ng are non-voting members. Rev. Morgan Wong, the senior pastor of CPC is an honorary member of the Board.

I must honestly say that the schools have some minor contraction in its enrolment for the past years which is genuinely challenging but nevertheless financially it is sound. The Board is grateful to Karen Leung for her long years of faithful service to the Preschool and we wished her well!

Ms. Samantha Chan, the Preschool Supervisor reports that currently there are 2 junior classes with 18 students and one large senior class with 15 students and a teaching staff that includes 2 full time staff namely Ms. Samantha Chan Ho, Ms. Sue Chen and a half time staff Ms. Kelly Kam.

It is heart-warming to have the Parents Advisory Council (PAC) members on board in supporting the school and connecting with other parents and friends in organizing the following activities: Grandparents' Appreciation Day, Easter Party, Field trip to Maritime Museum, Sports Day, Year-end and Graduation Ceremony and the annual church and preschool Summer picnic. Many thanks to PAC chair Ms. Tiffany Lee and her team of dedicated parents. The Board appreciates Elder Garland Chow and his team in making the picnic a success. Thanks to everyone for participating.

Ms. Grace Ng the Chinese Language Principal reports that the weekly Chinese Language school curriculum which offers students opportunity to learn both Cantonese and Mandarin Language happens on Friday afternoon, and the whole day Saturday. The current enrolment is 260 students from grade 1 to 6. In addition to the prescribed Chinese Language curriculum, Principal Grace Ng takes initiative as the school's mission to teach Christian moral values and character formation through Bible stories and the purpose is to share the Gospel of Jesus Christ, his life, death, resurrection and His reign in our lives with the students and their families. Annually, the whole

student body celebrates Christmas and concludes with graduation ceremony in June. The April Speech Festival is the main attraction for the parents and visitors to witness their youngsters' talent in speaking Chinese poetry, drama and songs, and or dialogue in Chinese Language! Awards are granted as a recognition of the students' lifetime achievements and the trophies are donated generously by Ms. Michelle Cheung. Thanks be to God for His wonderful provision!

It is my prayer and conviction that we must prepare ourselves to be ready for new possibilities and visions that God gives in the coming years. Our strength in the foreseeable future is the location and the changing neighbour-hood in the Oakridge area. We are so blessed that the plan for the construction of a new facility and development of a new church building are on the way to become a reality. Imagine the new opportunity opening before our eyes as God's witnesses.

The big challenge ahead is initiating a Day Care Program for three years old and under in addition to maintaining a uniquely Christian Preschool and Chinese Language Schools. Our prayers are these endeavors will bear more fruit for the kingdom of God by strategic planning and intentionally aiming at Gospel oriented activities in transforming lives. We plead with you to pray and be involved as part of the church community. We welcome your ideas and participation in any way you can.

We will continue to make presentations in 2018 and welcome feedback and suggestions from the congregation.
- 2. The Church rental properties which are managed by VHL, had a number of repair requirements and tenant related issues which occurred during the year. The Board continues to follow the principle of incurring only those expenses deemed necessary for safety of the tenants and to permit the properties to be rented.
- 3. During 2017 the Church offices were broken into and a number of items stolen from the Sanctuary, the items were replaced however the Board requests and encourages all members and adherents to be mindful and responsible in ensuring all doors remained locked and closed during non-worshipping hours.
- 4. Unfortunately leaks in the Church building have continued since repairs made in 2016. Given the pending redevelopment current focus is on ensure safety of facilities, please raise any items to the Board for consideration and awareness.
- 5. Board member Andrew Wong serving on the Property Development Task Force and leading the Transition Committee as part of the on-going Property Development activities.

As the needs and support to the church continue to grow, specifically with respect to the pending property development, the Board is in continued need of those who can support and execute on matters of interest on behalf of the congregation. As such, the Board strong encourages anyone who feels the calling in their heart to speak with an existing Board Member if they are interested in joining or assisting.

CHINESE ADULT SUNDAY SCHOOL

We continue to study from the same workbook as last year, entitled "The Truths of the Bible". Members of the class take turns in leading the individual lessons. We learned the following:

I. CHURCH MINISTER:

Being a minister in a church is a very high calling of God.

Let them do this with joy and not with groaning, for that would be of no advantage to you."
- (6) Responsibility: He is responsible to God for the soul of the flock.
 "We ask you, brothers, to respect those who labor among you and are over you in the Lord and admonish you, and to esteem them very highly in love because of their work. Be at peace among yourselves."

- 3) Chooses an appropriate minister for the congregation 4) When the minister is away he will be take care pulpit 5) Arrangements for special events such as evangelism, Vacation bible school, etc. 6) Assisting ministers in giving Holy Communion 7) Visiting patients, praying for them 8) leading the prayer in public 9) being good at dealing with church disciplines 10) assisting in the censorship of those who will be baptized.

2. Elder:

(1) What is deacons?

In the days of the apostles, the property of the church was public, when some complained that they did not enjoy a fair share of the meal, the apostles felt that their ministry was preaching and teaching, and when others were set up to take care of these vulgar and necessary things.

(2) Deacon eligibility

1) They must be well-appraised 2) People who are filled with the Holy Spirit 3) People who are wise enough 4) Dignified 5) not double-tongued 6) not addicted to much wine 7) not greedy for dishonest gain 8) Have a clean conscience 9) the husband of one wife 10) managing their children and their own households well.

(3) Deacon responsibility

1) take care of the church's business and financial needs 2) Collect offering, save money, pay salaries and utilities for ministers and church staff, and repair chapels 3) teach Sunday school 4) They should be a good role model for attending worship regularly.

PROPERTY DEVELOPMENT TASK FORCE REPORT

Every time we review the progress of the redevelopment project, we marvel at the hand of our Lord in leading the way to a renewal of the CPC Ministry via this building redevelopment.

Highlight of the stepping stones March 2017 to February 2018:

- 1) On September 19, 2017 City Council approved the rezoning of our church to 7 stories mixed use building with FSR of 3.08, the councillors took less than 15 minutes to approve our application and councillor Dr. Kerry Jang was also an alum of CPC Nursery School on Keefer Street. We have also achieved close to the maximum density allowed for this location.
- 2) On August 13, 2017 the congregation approved the listing of 6435 and 6459 Cambie Street duplexes with CBRE
- 3) On September 6, 2017 the PDTF signed a listing agreement in conjunction with 6409 Cambie Street to list all three properties at the same time.
- 4) On October 26, 2017 CBRE analyzed various offers and recommended the offer of Commodious Development. A counter offer was made and was accepted. The properties were sold for \$27.3 Million. Commission would be paid to CBRE from this sale amount. We have received an initial deposit of \$3M and the rest on the closing date on October 3, 2018. On November 5th, the congregation voted to accept this offer.
- 5) On November 26, 2017, PDTF submitted a comprehensive two part report to the Westminster Presbytery. Part 1 sought the approval of the Westminster Presbytery for the sale of the two duplexes (29 pages). Part 2 sought the approval of the Westminster Presbytery for the Redevelopment (68 pages). After many sleepless nights and overtime work to prepared these reports and faced the Property and Finance Committee on December 4, 2017 with CPC's presentation. On December 5, 2017 the Presbytery voted to approve the sale of the duplex properties as per our Sale agreement. An escrow for the sale must be set up as the funds are intended only for the redevelopment of the Church.
- 6) Between November and December 2017, GBL revised the 4th floor plan to add two more classrooms, moved the Manses to the 3rd Floor. Air space sale will be for 4th to 7th floor.
- 7) On January 17, 2018 GBL submitted to the City of Vancouver documents and updates to complete the rezoning process and apply for a Redevelopment Permit.
- 8) On February 15, 2018 the National Church Architecture Committee met to discuss the architectural design for our Church development. On February 20, 2018 we received word from the General Assembly that the committee deem our drawings acceptable. A further report outlining why we wish to construct this building is to be submitted.
- 9) On February 28, 2018 we will have a kick off meeting for the next phase of design.

- 10) Andrew Wong has started the transition committee motion.
- 11) GBL will assist the transition of CPC Nursery School to relocate to Kerrisdale Presbyterian Church with plans for COV.

In His Service, CPC Property Development Task Force

RE-DEVELOPMENT FUND-RAISING COMMITTEE

This committee was formed by Session in April 2016. Member included: Grace Ng Wong and Victor Ling (co-chairs), Ada Con, Billy Lo, Glady Kwan, Jean Ip (deceased) and Mary Lam. Sue Yuen and Tim Tam stepped down for health reasons. The objective was to raise \$2 Million for the Redevelopment of our church property. Funds will be raised from the congregation and friends of the church. Donors will be given opportunities for naming spaces and to give in memory of their loved ones.

The fund-raising campaign was launched at the Thanksgiving joint service on Oct 9th, 2016 where everyone received a 2020 Vision card with the information on the building project. The theme was taken from 2 Corinthians 9:7 "Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver".

May we all seize such an opportunity; do our best, to build a House for the Lord! What a blessing! God's blessings are like shower pour upon us; His love will also flow down to His children.

Throughout this past year we heard inspiring testimonies from congregation members as to why they decided to support this redevelopment project. A recurring theme was gratitude for God's blessings, His faithfulness, and loving care. Another was appreciation of how this congregation has been welcoming and generous. We will hear more testimonies this year. This building project is a wonderful opportunity to share with friends our 2020 Vision.

Praise the Lord, as of February 18, 2018 the total amount pledged was \$1,303,646.00 of which \$843,885.00 was received in cash or securities.

We plan to wrap up this campaign by Thanksgiving Sunday of 2018 on October 7, 2018. Please continue to pray for this redevelopment project.

SUNDAY SCHOOL

"Let the little children come to me and do not hinder them for the kingdom of God belongs to such as these."

We praise and thank God for his continued guidance over our Sunday School. Our staff consists of 12 dedicated teachers and three substitutes who give his/her time and commitment to teach God's Word to children, youth and adults each week. As a staff, we meet two to three times per year at a Potluck Lunch to plan for the year's activities. The children continue to bring offering each Sunday and in 2017, we used our funds to support Presbyterian World Service and Development programs and Camp Douglas. At Christmas, the SS students brought a total of three boxes canned goods to support the Food Bank.

We are continuing our monthly Sunday School Teachers' Prayer meetings on the first Sunday of each month. All congregation members are welcome and our purpose is to pray for the needs of the Sunday School and the church and to praise and thank God for his blessings. We are thankful to God that our numbers have increased slightly and we hope that more people will join us in 2018.

Our registration from preschool to College and Career classes was 33 students. We also had one Adult Bible class of six participants and a Mandarin Adult Bible Study with 5-6 participants. Two members from the latter class were baptized at Christmas. Our total enrolment continued to decrease this year due to a lack of students from the preschool level to Grade 4/5. It seems to be the sign of the times that other activities take precedence over coming to Sunday School. Our children today need to know the gospel to help them face the temptations and distractions in the uncertain and fractured world we live in. Our weekly attendance from preschool to adult classes was about 40-45 students.

Two other programs that are a part of our Sunday School include: Kids' Kare and the Youth Orchestra. The Kids' Kare program occurs during our English Worship service from 9:30-10:45 a.m. Each Sunday, members from the congregation volunteer to look after the children from preschool to Grade 4/5. Bible lessons and Christian videos are provided. There are 1-2 children who join this program while the older children now sit with their parents in the worship service.

Our Youth Orchestra continues to meet for practices on Sundays from 12:30 to 1:00 p.m. and have participated in several events this year.
